C. PERMIT HISTORY

In addition to the Environmental Overview chapter of the Master Plan, the objective of the Permit History supplement is to provide a summary of the previously obtained permits from the Maine Department of Environmental Protection by the Auburn-Lewiston Municipal Airport.

This information was obtained from the Site Location of Development Act (SLODA) and Stormwater Law Permits Google Earth database file, and permit history records provided by the Airport. Any records pertaining to the Airport located in the Central Maine Regional Office DEP File Room were not reviewed as a part of this effort.
